申請「2021/22幼稚園入學註冊證」：

1. 在幼稚園教育計劃之「免費優質幼稚園教育計劃」下，每名可在本港接受教育的學童只會獲發一張註冊文件，而所有參加「計劃」的幼稚園，只可取錄持有有效註冊文件的學童。
2. 家長須於2020年9月至11月期間為其子女向教育局申請「幼稚園入學註冊證」。「註冊證」於9月開始接受申請，屆時教育局會公布申請細則，並會在教育局網頁(www.edb.gov.hk)上載詳情。如申請人在遞交申請時已提供全部所需資料及文件，教育局一般可在六至八個星期內完成審核，並以郵遞方式發放「註冊證」給合資格接受「計劃」資助的申請人。
3. 如學童可於本港接受教育但不合乎資格接受「計劃」資助而未能獲發「註冊證」，教育局會為有關學童發出「幼稚園入學許可書」，學童可憑「入學許可書」註冊並入讀參加「計劃」的幼稚園，惟其家長須按註冊入讀之幼稚園的收費證明書繳付未扣減「計劃」資助前的全額學費。

收生準則：

1. 面見表現
 2. 申請人的兄弟姊妹現正在本幼稚園就讀獲優先考慮
備註：如申請全日班學位，有家庭需要的申請人可獲優先考慮
(請留意學位所限，並非所有符合優先考慮的申請人均會獲取錄。)
- 父母雙方在職，其中一方從事全職工作

面見安排：

1. 本幼稚園會安排面見所有申請入讀者

4. 家長須陪同兒童參與面見 (一位成年人)

取錄結果公布：

本幼稚園將於2020年12月將取錄名單張貼於本園大堂通訊欄，同時亦會以電郵 / 郵寄方式通知家長幼兒班取錄結果。

註冊安排：

1. 正選生：家長須於 2021 年 1 月 7 日至 9 日(「統一註冊日期」)內的指定時間到本幼稚園辦理註冊手續，並須提交「註冊證」/「入學許可書」及繳交註冊費。
2. 備取生：倘學校尚有學位空缺，本園將會向個別學生發出通知書，請家長於指定日期到本幼稚園辦理註冊手續，並須提交「註冊證」/「入學許可書」及繳交註冊費。
3. 家長請留意，如未能在指定的註冊日期提交「註冊證」/「入學許可書」，本幼稚園或未能為獲取錄兒童完成手續，因此家長務必於指定日期內向教育局申請相關註冊文件。
4. 2021/22 學年的註冊費為港幣970元正、全日班註冊費為港幣1,570元正。如有關兒童入讀本校，本校會於9月退回註冊費，但若家長於註冊後決定為子女轉校，請以書面通知本幼稚園。本幼稚園會退回「註冊證」/「入學許可書」，但註冊費將不獲退還。在取回「註冊證」/「入學許可書」後，本幼稚園亦不會再為該兒童保留學位。

Online Admission

Distribution Period

1. Date: Start on 7th September 2020
2. Time: 9:00a.m.-11:30a.m., 1:30p.m.-4:00p.m. (Monday to Friday) / 9:00a.m. to 12:00n.n. (Saturday)

Return of Application Forms (No set quota for the kindergarten)

1. Date: 28th September, 2020 (Wednesday) to 23th October, 2020(Friday)
2. Time: 9:00a.m.-11:30a.m. , 1:30p.m.-4:00p.m. (Monday to Friday) / 9:00a.m. to 12:00n.n. (Saturday)
3. Return method: Submit the application form in person [together with the documents required (including identity document)]
4. Application fee: HK\$40 (to be collected together with the application form). The application fee is non-returnable whether the application is successful or not.

Application for the "2021/22 Registration Certificate for Kindergarten Admission"

1. Under the kindergarten education scheme (Scheme), each child who can receive education in Hong Kong will only be issued a registration document and all Scheme-KGs can only admit students holding a valid registration document.
2. Parents are required to submit an application for the "Registration Certificate for Kindergarten Admission" (hereafter referred as "RC") to EDB from September to November 2020. The "RC" will be open for applications in September 2018and EDB will announce and upload the details of application onto EDB' s website(link to be inserted) in due course. Upon receipt of the applications with all necessary information and documents provided, EDB will generally take six to eight weeks to complete processing of the applications and issue the "RC" to applicants who are eligible for receiving subsidy under the Scheme by post. If a student cannot obtain an "RC" as he/she can receive education in Hong Kong but is not eligible for receiving subsidy under the Scheme¹ , EDB will then issue a "Kindergarten Admission Pass" (hereafter referred to as "AP") to the student concerned for registration and admission to a Scheme-KG but the parents concerned are required to pay full school fees before deduction of subsidy under the Scheme as shown on the Fees Certificate of the KG to which the child is admitted.

Admission Criteria

1. Interview performance.
2. The applicant with sibling(s) currently studying in the kindergarten will be due a priority consideration.
3. The applicant from families in need will be given priority consideration when applying for whole day (As the number of school places is limited, please understand that not all applicants fulfilling the priority consideration will be guaranteed a school place.)

Interview Arrangements

1. The kindergarten will arrange interview for all applicants.
2. Interviews will be start on 1th November 2020 and notification will be sent by email or mail.
3. Individual nterviews will be arranged.
4. Parents should accompany their child for the interview.(Only one person)
5. Please bring along the documents listed below on the interview day:
 - Original copy of birth certificate
 - 6 reply envelopes with the correspondence address and enough postage stamp on each (only available for the applicants with no email address provided)
 - Original copy of the Bank Slip(if the application fee is paid via online admission system or by ATM/by counter)

Announcement of Admission Results

We will inform parents of the K1 admission results before December 2020 by email or by post (for applicants who cannot provide their email address).

Registration Arrangements

1. Successful applicants: Parents should complete the registration procedures for their child from 7th to 9th January 2021 ("Centralised Registration Dates") by submitting the "RC" / "AP" to the kindergarten and paying the registration fee.
2. Applicants on the waiting list: Parents should complete the registration procedures for their child according to the specified date set by the school. Parents are required to submit the "RC" / "AP" to the kindergarten and pay the registration fee.
3. Please be reminded that if parents cannot submit the "RC" / "AP" during registration, the kindergarten may not be able to complete registration for their child. Hence, parents are required to submit application for the registration document to EDB within the specified period.
4. The registration fee for 2020/21 K1 is HK\$970(half-day) / HK\$1,570(whole-day). If the child concerned studies in the kindergarten, the registration fee paid will be refunded in September. Should parents decide to change school after registration,please notify the kindergarten in writing. The kindergarten will return the "RC" / "AP" but the registration fee will not be refunded. Upon obtaining the "RC" / "AP" , the kindergarten will no longer keep the school place for the child.
